**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PARADISE  
AUTHORIZING DESTRUCTION OF CERTAIN TOWN RECORDS PURSUANT TO  
GOVERNMENT CODE SECTION 34090**

**WHEREAS**, Government Code Section 34090 authorizes the head of a city department, with the written consent of the city attorney, to destroy certain records over two years of age upon approval of the legislative body; and,

**WHEREAS**, the Town Clerk would like to destroy certain records maintained in the Town Clerk's Department as set forth on the attached Exhibit "A"; and,

**WHEREAS**, the Town Attorney has consented to the destruction of such records.

**NOW, THEREFORE**, the Town Council of the Town of Paradise does resolve as follows:

**SECTION 1:** The Town Clerk of the Town of Paradise is hereby authorized to destroy the records set forth in Exhibit "A" of this resolution.


