

**TOWN OF PARADISE
RESOLUTION NO. 10-25**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PARADISE,
CALIFORNIA, ADOPTING DIRECT ASSESSMENT FOR ADMINISTRATIVE
CITATION PENALTIES FOR FISCAL YEAR 2010/11 AND AUTHORIZING THE
TOWN MANAGER AND THE TOWN ATTORNEY TO EXECUTE THE
PROPOSITION 218 CERTIFICATION OF TAX BILL LEVY**

WHEREAS, the Town of Paradise (the “Town”) is a municipal corporation duly organized and existing under and pursuant to the Constitution and laws of the State of California; and

WHEREAS, Butte County has notified the Town that they are no longer able to “Teeter” the administrative citation penalties that are sent to Butte County for the annual tax roll; and

WHEREAS, Butte County requires the Town to establish a new non-teeter tax code for the administrative citation penalties that will be sent to Butte County for the annual tax roll.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PARADISE AS FOLLOWS:

SECTION 1. The Town of Paradise has complied with all laws pertaining to this levy, including Proposition 218.

SECTION 2. The charges being levied are in accordance with the administrative citation penalties against each parcel without regard to the valuation of the property.

SECTION 3. The charges are being added to the property tax bills of the owners of the parcels because the charges are delinquent. The authority to add the charges to the tax bill comes from Town of Paradise Ordinance No. 449.

SECTION 4. The administrative citation penalties contained in the electronic media are hereby ordered levied.

SECTION 5. The Town Manager and the Town Attorney are hereby authorized to each sign the Proposition 218 Certification of Tax Bill Levy.

SECTION 6. Tax Code 99500 Town of Paradise Nuisance Abatement is hereby designated as the appropriate tax code for the Town administrative citation penalties.

SECTION 7. The Town Clerk shall attest to the adoption of this Resolution.


