INSTRUCTIONS TO APPLICANT

Theaters, Tent Show and Playhouses

In order to obtain your local permit for a Theater, Tent Show or Playhouse in the Town of Paradise, please complete the following items and return them to Paradise Town Hall Attn: Planning Director. Applications shall be filed not less than fifteen (15) days or more than ninety (90) days before the date(s) during which the proposed activity is to be conducted.

- Completed and Signed Theaters, Tent Shows, and Playhouses Application
- Theaters, Tent Shows, and Playhouses License fee
 - Initial Fee made payable to the Town of Paradise (See current Master Fee Schedule)

When the net proceeds raised by the theater, tent show or playhouse are to be used for charitable, religious, patriotic, educational, civic or other community purposes or if no admission charge is made, the Town Manager may authorize Town issuance of the business license without payment of the Town fee and for a time period not to exceed ten (10) consecutive days or a cumulative total of twenty (20) days per calendar year.

- Approval by Town Manager

You will be notified when your application has been approved. At that time an appointment will be scheduled to pick up your Theaters, Tent Show and Playhouses license.

Theaters, Tent Show and Playhouses licenses are valid for the period of the event, not to exceed ten (10) consecutive days or a cumulative total of twenty (20) days per calendar year.

It is the responsibility of the applicant to know and understand the relevant Town municipal code section and any other state or federal codes which may apply.

• It is unlawful for any person or entity to violate or fail to comply with the provisions of chapter 5.07 of the Paradise Municipal Code. Such violation shall be punishable as an infraction. • Under Federal and State law, a One Dollar (\$1.00) fee may be collected in addition to any other fees for compliance with disability access laws.
