**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PARADISE  
RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION CONSOLIDATED  
WITH THE STATEWIDE GENERAL ELECTION HELD ON NOVEMBER 2, 2010,  
DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW**

WHEREAS, a General Municipal Election consolidated with the Statewide General Election was held and conducted in the Town of Paradise, California, on Tuesday, November 2, 2010, as required by law for the purpose of the election of two Town Council Members for a four-year term each; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; voting precincts were properly established; election officers were appointed and in all respects, the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, pursuant to Resolution No. 10-24, adopted by the Paradise Town Council on July 22, 2010, the Butte County Clerk canvassed the returns of the election and has certified the results to this Town Council, a copy of which is marked Exhibit "A" and attached to this resolution;

NOW, THEREFORE, the Town Council of the Town of Paradise, does resolve, declare, determine and order as follows:

Section 1: That the whole number of votes cast in the Town was 18,084;

Section 2. That the names of persons voted for at the election for Member of the Town Council are as follows:

Section 3. The Town Council does declare and determine that: Tim Titus was elected as a Member of the Paradise Town Council for the full term of four years; and, Scott Lotter was re-elected as Member of the Paradise Town Council for the full term of four years; and,

Section 4. Exhibit "A" attached to this resolution shall be the official record of the Town of Paradise as to the result of the election showing: (1) The whole

number of votes cast in the Town; (2) The names of the persons voted for; (3) For what office each person was voted for; (4) The number of votes given at each precinct to each person; and, (5) The total number of votes given to each person.

Section 5. The Town Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the Town Clerk and authenticated; shall administer to each person elected the Oath of Office prescribed in the Constitution of the State of California; and, shall have the persons elected subscribe to the oath and cause it to be filed in the office of the Town Clerk; and, each and all of the persons so elected shall be inducted into the respective office to which they have been elected.

Section 6. The Town Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.




