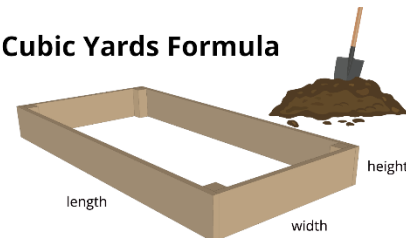

**Example calculation for volume in cubic yards**

$$\begin{aligned} \text{length (ft.)} \times \text{width (ft.)} \times \text{height (ft.)} &= \text{ft}^3 \\ 40 \text{ ft.} \times 40 \text{ ft.} \times 1 \text{ ft.} &= 1,600 \text{ ft}^3 \\ 1,600 \text{ ft}^3 \left( \frac{1 \text{ CY}}{27 \text{ ft}^3} \right) &= 59.3 \text{ CY} \end{aligned}$$
