- Mark stake with a finish grade, so they know where they can sit their risers

#### 4. Planning Department - SolarAPP+

Solar Contractors can now apply for residential roof mount solar permits online. SolarAPP+ uses a software to automate and streamline the plan review process. Registered contractors can use SolarAPP+ for faster rooftop solar permits. With an approval ID from SolarAPP+ contractors can submit their approved plans to the Town of Paradise and instantly receive a permit. Installation practices, workmanship, and adherence to the approved design are verified in the inspection process.

#### Who Can Use SolarAPP+

Licensed B-General, C-10 Electrical, or C -46 Solar Photovoltaic contractors are eligible to use SolarAPP+. Contractors must register and become certified by SolarAPP+ before submitting applications for plan review.

- Winter Holiday Safety, thinking about fire dangers that happen inside the building.
  Christmas trees, decorating, candle safety. Now is a good time to test your smoke and C O alarms and fire extinguishers.
- Have a home escape plan. Make sure when the smoke alarm goes off, your family knows; two ways out, and knows where to meet.
- Keep trees at least 3feet away from heat sources
- Do not block windows and doors with decorations.
- Don't leave burning candles unattended, do not put candles on a combustible surface, and keep the kids away from the them.
