#### INSTRUCTIONS TO APPLICANT

#### **Outdoor Festivals**

In order to obtain your local permit for Outdoor Festivals in the Town of Paradise, please complete the following items and return them to Paradise Town Hall Attn: Town Manager. Applications shall be filed not less than forty (40) days or more than ninety (90) days before the date(s) during which the proposed activity is to be conducted. By applying for an Outdoor Festival Permit, you are also registering for the Town's Business License. (Business License Fee Waived)

- Completed and Signed Business License Application
- Surety Bond (If applicable, deemed necessary by Town Manager)
- Attach statement with details per section 5.09.020 (1-6)
- Outdoor Festivals License fee
  - o Initial Fee made payable to the Town of Paradise (See current Master Fee Schedule)

A neighborhood or community benefit organization, constituted for charitable or religious purposes, shall be exempt from the requirement of license application and related application fee submittal provided the net proceeds from such outdoor activity do not inure to the benefit of any private person, partnership or corporation.

You will be notified when your application has been approved. At that time an appointment will be scheduled to receive your Outdoor Festival license.

Outdoor Festival licenses are valid for the period of event.

It is the responsibility of the applicant to know and understand the relevant Town municipal code section and any other state or federal codes which may apply.
