Commercial design review is required for new signs and new commercial / industrial buildings and/or structures, and façade renovation projects within the Town limits excluding single family residential uses. Design Review is evaluated for compliance with the Town's Design Standards, the Town's General Plan, Zoning Ordinance, applicable specific plans, and other related town standards.

All boxes must be checked off and application must be signed by applicant and property owner for application to be deemed complete.

Town of Paradise New Construction and Façade Renovation Design Review Application

Step 1: Applicant Submits a complete application, which includes:

- Completed application, signed by property owner and applicant along with the required fee.
- Project Description
- Building elevations of all building facades, which include a topographical building perspective 2 hard Copies or 1 Electronic copy
- Professionally prepared colored rendering 2 hard Copies or 1 Electronic copy
- Location and size of all proposed signs or existing sign structures 2 hard Copies or 1 Electronic copy
- Materials/Production information, which includes description of types of materials, colors, treatments, etc. 1
 packet
- Floor Plan drawn to scale 2 hard Copies or 1 Electronic copy
- Site Plan drawn to a common engineer's scale and clearly dimensioned 2 hard Copies or 1 Electronic copy
 - Scale and north arrow
 - Street addresses of lot or lots proposed to be developed
 - Size of lots accurately dimensioned
 - Location and size of all existing and proposed structures
 - Location and size of all parking stalls
 - Location of all landscaped areas
 - Location of mechanical equipment & trash area(s)
 - o All existing easements and all building and setback areas

Step 2: Application is deemed complete by Town Staff and an in-house staff review is scheduled

Step 3: Decision Letter

Applicant receives a letter of approval or denial on the proposed project at least 15-days after the completed application packet is submitted. If an incomplete application is submitted, staff will contact the applicant to complete the packet for Staff review.

A letter of approval allows the applicant to submit plans for the building permit/plan check process.

Note: If other land use permit and reviews are required for a new project or façade renovation, such as: landscape review, site plan review, administrative permit, some of these requirements may be processed simultaneously with the Design Review process.
